1 APOLOGIES: - were accepted from Mr. Julian Wyatt

2 DECLARATIONS OF INTEREST: - Mr Lewis Price declared an interest in Planning Application DMN/111856/F

3 MINUTES OF PREVIOUS MEETING The Minutes were agreed and signed by the Chairman, as a true record.

4 Report from Cllr John Hope:-Marches Redundant Building Grants Programme - £1.5 million grant from HMG to support small businesses and start-ups in Hfdshire, Shropshire & Telford to bring unused buildings back into productive economic use - will provide up to £50,000 to small businesses. To create over 300 direct jobs.

Budget Savings – made over £10 million savings in 2011/12. Further £7 million in 2012/13 – savings in way services delivered rather than services themselves.

H'fd & W'cester Fire Authority will be keeping local stations open. Police may join Stations with Fire Service in Kington to make savings.

Presentations from Council and NHS at Lady Hawkins – 22nd November, 7.30pm

5 PUBLIC PARTICIPATION PERIOD: - A group of residents from Upper Court voiced their concerns about the speed of traffic through Eardisley. Was there any possibility of traffic calming measures being introduced? The S.I.D. to be in Eardisley during December and the information/statistics from this would be fed back to Amey. Also the lack of a pavement from Upper Court down to the Village was raised, dangerous walk for schoolchildren to/from School bus. Cllr John Hope said he would arrange an urgent meeting for the residents with Andrew Lee-Jones of Amey to discuss their concerns

6 MATTERS ARISING (not on agenda) - Eardisley Flooding – Millstream Gardens. Martin Jackson concerned about new trees planted – discussions need to take place with residents

7 Flood Alleviation Meeting – held in EVH on Thursday 6th October. The Chairman gave a brief resume of the meeting which was led by Martin Jackson. The silt clearing machine had been in Eardisley clearing the culvert. The smell at the bridge seems to have disappeared. None of the landowners had been contacted by Martin Jackson – this was to discuss what remedial measures could be taken. Grant applications for help with costs in Eardisley and Whitney to go forward in June 2012. Clerk to contact Martin Jackson to find out what progress is being made and to request copies of the applications when available.

8 Neighbourhood Plan Meeting – attended by Clive Skelton, Nancy James and Andrew Layton.

Nancy James gave a presentation of the meeting - see attached sheet for a summary of Nancy's notes.

It was **AGREED** to hold an extra-ordinary meeting of the PC to put together their LDF response. The meeting to be held at 7.30pm on Monday 28th November in Whitney-on-Wye Village Hall. All interested Parish Councillors to attend.

9 Speed limit in Winforton: - Cllr John Hope reported that a traffic survey in Winforton to be held in 10 days; it is likely that the speed limit will be reduced to 30mph.

10 Kington Medical Centre and Eardisley Surgery: - Clerk had requested news about both from the Practice Manager but nothing received. The new medical centre is progressing well.

11 WIND TURBINE GROUP: – Nancy James stated nothing specific to report. Clive Hall has not heard anything about the guidelines being drawn up by the Welsh Assembly Government which would indicate that Herefordshire is not being considered as part of the guidelines

12 P3 Scheme: – Footpaths. Mr P Whittall, EGPC FPO reported that Alan Watkins and he had received training as FPOs and Phil Eggerton as a P3 contractor. The training was a useful update for all concerned. P3 work can now start in earnest.

Mr A Preece has agreed to the replacement of a stile near Hobby Lyons bridge with a metal kissing gate.

There is some concern over a footbridge at Whitney which belongs to Network Rail – Clerk to follow up.
