Clive Skelton welcomed Lynda Wilcox – Chief Executive of Herefordshire Association of Local Councils (HALC) – who explained some of the changes which will impact on Parish Councils. This includes the Localism Bill with all its implications. The Parish Plan should be refreshed every 5 years, a grant is available - to access the grant a resolution has to be approved to update the Parish Plan. Guidance is available from local Officers. Neighbourhood Plans (developed from the Parish Plan) which refer to local planning can only be completed by PC's.

- **DECLARATIONS OF INTEREST: -** The Chairman declared an interest in agenda item 16 Planning **DMN/112289/F**
- **3 MINUTES OF PREVIOUS MEETING:** the Minutes were **AGREED** and signed by the Chairman, as a true record.
- 4 Report from Cllr John Hope:-

This included – Rotherwas Enterprise Zone; Superfast Broadband in rural areas; simplified planning; £4.9 million to be spent on upgrading Broad St., Hereford. Meeting for all of Castle Ward re. planning for the local area over the next 20 years to be held in EVH on October 20th at 7pm.

Flood Alleviation meeting at EVH on Oct.6 $^{\rm th}$ at 7pm. Cllr Hope has invitation letters to deliver to people likely to be affected.

- **PUBLIC PARTICIPATION PERIOD: -** Speed limit enforcement in Winforton raised by Mrs Y King. Cllr Hope had asked Amey/Herefordshire Council to contact Mrs King. Mr A Lee-Jones had done so and discussed proposal for a 30mph limit. Safer Roads Partnership monitor speed limits they meet bi-monthly. Concerned residents should approach PC. Mr Julian Wyatt had computer printouts from the last deployment of SID in Winforton over 50% of traffic was exceeding the speed limit. Enforcement of speed limit is the key.
- It was **RESOLVED** that the Chairman will write to Safer Roads Partnership with facts and figures.
- **MATTERS ARISING:-**Work has started on the new Medical Centre. Mr Paul Whittall asked if Eardisley residents were aware that Eardisley Surgery could close in 2013 if nothing is done to update it. It was **RESOLVED** that Cllr Hope checks progress and reports back to PC
- **7 WIND TURBINE GROUP** –Report: Welsh Assembly Government still working on the criteria that will apply to movement of wind turbine traffic. Clive Hall to go to a meeting on Sept.29th
- **8 P3 SCHEME:** A report was given by the Chairman of the Open Meeting held on Monday July 25th at New Strand it was attended by approx. 10 people including representatives from Amey, PC FP Officers, Chairman and Mr P Eggerton.
- **9 MOBILE LIBRARY SERVICE:** local support for a volunteer Community Library as a response to the loss of the mobile library service. One possible venue could be a refurbished Snooker Room.

It was **RESOLVED** to support the idea of a Community Library.
