- 1 **APOLOGIES:** - received and accepted from A Layton, L Price. None received from A Preece; R Taylor; A Raymond; A Watkins
- 2 **DECLARATIONS OF INTEREST:-NONE**
- 3 **MINUTES OF PREVIOUS MEETING** The Minutes were agreed and signed by the Chairman, as a true record.
- 4 **Report from Cllr John Hope:** - Hereford Council has asked the Highways Agency about speed limit countdown markers for Eardisley but they said no.
Meeting held with Martin Jackson from Amey at Whitney re. flooding – he is trying to locate funding.
- 5 **PUBLIC PARTICIPATION PERIOD:** - NONE
- 6 **MATTERS ARISING:** - Martin Jackson had said he would let the PC have copies of his applications for funding for flood alleviation schemes in Eardisley and Whitney. As these have not yet been received Clerk to contact him and ask for copies.
Trees still overhanging main road in Whitney – Cllr Hope to follow up.
Request from resident for 'No Dog Fouling' signs along the Almeley Rd. Clerk reported that signs cost £10 from Amey.
It was **AGREED** to buy 2 signs and Mr C Davies to put them up.
- 7 **WIND TURBINE GROUP** – still ongoing with the application from Scottish Power with the Secretary of State. Possibility of a public enquiry. There is a need for a meeting with Clive Hall, Hereford Council to find out exactly what is happening.
- 8 **NEIGHBOURHOOD PLAN:** - 4 Parish Councillors attended a meeting put on by Hereford Council to find out more. Still very much in its early stages. Crucial that local people are involved – there will have to be a public village meeting. There is a need to set up a Steering Group initially from within the PC. It was **AGREED** to have an extra-ordinary PC meeting solely to discuss this matter. Clerk to check availability of Village Hall for Monday August 13th or New Strand.
- 9 **Register of Interest Forms:** - Clerk distributed these to those Cllrs. who had not already received them electronically. She explained that these forms replaced the ones filled in after the last Parish Council elections. She was going to a meeting about the forms that week and hoped to know more by the next PC meeting.
- 10 **Eardisley Speed Limit:** - concern raised over lack of enforcement. Cllr. Hope to speak to Dick Allford – local Community Support Officer.
- 11 **Eardisley Surgery:** - Practice manager – J Rudge had told PW that she was in contact with Alan Cooper at the planning dept. about draft proposals for improvement to the surgery. Cllr Hope said practice responsible for internal structure and Hereford Council responsible for the outside.
New Medical Centre in Kington is 6 weeks late.
Clerk to invite Dr King to next PC meeting.
- 12 **Winforton Speed Limit:** - notification has been received that this will be reduced to 30mph.
- 13 **New Code of Conduct:** - Hereford Council to provide a template to use if required. Clerk to attend meeting later in week and will report back at the next PC meeting.
