Lynda Wilcox from HALC gave a presentation about Parish Councils and Neighbourhood Plans. She went through how NPs developed and the current position locally in light of HC's lack of a Core Strategy.

Lynda answered questions on PC working groups; section 106 money and how the NP affects planning applications.

The Chairman announced his intention to stand for election as Ward Councillor for Castle ward following the retirement of Cllr. John Hope. He will also stand for the Parish Council.

- 8. NEIGHBOURHOOD PLAN: -**

Current state:

The Eardisley Group Plan cannot be submitted because the Herefordshire Core Strategy is not in place yet.

In Eardisley the Barley Close application has been accepted, bringing the housing numbers to which the Village is committed to 34 which exceeds the 29 Eardisley is required to build over the NP period to 2031.

In Winforton, the application for 4 houses near the Sun Inn has been passed bringing 'commitments' to 8 which exceeds the 7 required up to 2031. Applications for 19 more (Courtlands farm 14; West of Poppins 5) will be decided shortly. The application for 4 houses north of Courtlands Farm has been refused.

In Whitney, no applications have been submitted but there is still uncertainty as to where houses can be built without putting some existing homes at risk of flooding.

The steering group must consult again with residents of each village in order to ensure that the housing numbers and locations stated in the final Plan are what residents will accept. These further consultations will have significant cost implications for the PC because more planning advice will be required.

In good faith the steering group raised grant funding to support budgeted expenditure throughout the Neighbourhood Planning process. That process has reached the point where HC should be bearing the funding of post-submission activities (inspection and referendum). There are no funds left for additional pre-submission costs.

In the December SG meeting, members approved the principle of using up to £3,000 of precept money.

Along with other NP parishes in Herefordshire, we will be challenging the contradictory stance being taken within the County in which the dedicated NP Team encourages and supports the development of NPs (10% of the Plans in England) while the planning committee races to approve applications that unpick the long-term benefits the NPs are seeking to provide.
