## Minutes of the Annual Parish Meeting: - 17<sup>th</sup> May 2010 – Eardisley Village Hall

**3 - Declarations of Interest – NONE**

**4 - Minutes of previous meeting 15<sup>th</sup> March 2010** – these were agreed and signed by the Chairman, as a true record.

**6 - Report from John Hope:-**

i) - He thanked the PC for their help.

ii) - Offices in Plough Lane have been purchased and will be the main centre for HC/NHS. Looking to reduce personnel by 100

iii) - Amey are saving HC £1,000.000 p.a. They are coping well with the challenge. Pot-holes can be reported on 01432 261800. They are dealing with 17,000 annually instead of 3,000.

iv) - New cattle market – work starts this month. A cinema, department store and small food market will be built on the old market site.

v) - Recycling – tripled in the last 12 months. Service operated during the bad weather.

**7 - Public Participation Period:-**

Matters discussed included;

i) – Wind turbine transportation – a meeting due to be held shortly as no contact since the trial run

ii) – Whitney – traffic lights since the road slippage, stalled because of the difficult site

There would be a clause in the sale preventing development of the site. The car park is currently used by the school and the surgery - ownership needs to be clarified. **10 – Rave in Eardisley** – No complaints this year (several received in 2009) The whole thing was well organized and run. No problems reported. An enforcement team + licensing team + Police officers in the village. Cost for this –very high

**11 – Kington Medical Centre** – already discussed. Site opposite Arrow Plant Hire, Planners had recommended refusal but overturned by Councillors

**Eardisley Surgery** – repeat prescriptions can be a problem, they can be emailed

**12 – Chevrons** (bend at S end of Eardisley) – J Hope reported that there are 2 chevrons again

**Traffic Calming measures in Eardisley** – it was **resolved** to approach English Heritage for money to fund a professional report re. the traffic calming

**13 – Freighter Lorry** – it was **resolved not** to order the freighter lorry as the charge had now increased to £380.00

J Hope reported that there will be a new recycling facility in Kington at Arrow Plant by end of 2010

**14 – Footpath-Upper Court to Eardisley** listed building consent has been sought to reduce the steps at Upper Court to enable footpath

**15 – Response to Place Shaping Paper** – awaiting response from HC to Chairman's letter. Shape of Herefordshire until 2026

**16 – Public Transport Issues in Eardisley** – the 446 route Almeley to Hereford service currently goes via Kinnersley. From September 2010 the service will revert back to the old route not via Kinnersley as no-one used it. There is a problem with the times of the Kington bus. Matter to be raised with transport dept.
